

## Statement of Conformity **Uyghur Forced Labor Prevention Act (UFLPA)**

On 23 December 2021, President of the United States signed into law the Uyghur Forced Labour Prevention Act of 2021 (The "Uyghur Act" or "UFLPA"). The UFLPA prohibits the importation of goods made in the Xinjiang Uyghur Autonomous Region of the People's Republic of China ("Xinjiang") based on the presumption that all goods made in the region are made with forced labor.

The Act establishes a rebuttable presumption that the importation of any goods, wares, articles, and merchandise mined, produced, or manufactured wholly or in part Xinjiang or produced by certain entities which are included in the UFLPA entry list, is prohibited by 19 U.S.C. 1307 (U.S.C. Title 19 - CUSTOMS DUTIES (govinfo.gov)) and that such goods, wares, articles, and merchandise are not entitled to entry to the United States.

## **Recom Technologies Statement**

We, Recom Technologies, hereby state that the products supplied by our subsidiaries or parent or affiliated companies do not contain any material mined, manufactured or produced from China's Xinjiang Uyghur Autonomous Region.

We, furthermore affirm that Recom Technologies conducts, as part of its standard procedure, extensive due diligence to ensure that none of the components or materials comprising its panels, originate from the following suppliers: Hoshine Silicon Industry (Shanshan) Co., Ltd, Xinjiang Daqo New Energy Co., Ltd, Xinjiang East Hope Nonferrous Metals Co., Ltd, Xinjiang GCL New Energy Material Technology Co., Ltd, Xinjiang Production and Construction Corps (XPCC), and from none of the suppliers included in the UFLPA Entity List, as mentioned in the following link: https://www.dhs.gov/uflpa-entity-list.

Furthermore, Recom does not use, directly or indirectly, forced labour for any part of products or raw materials, and complies with all requirements set under Uyghur Forced Labor Prevention Act (UFLPA) in the USA. Each of the Products (and the components of each Product) supplied by Recom is free of any materials which would prevent its (or any part of its) importation into any of the USA ports, and will not contain, be derived from or produced using any silica-based products manufactured or processed by, or procured from, Hoshine Silicon Industry Co. Ltd.

As a general principle, Recom Technologies unequivocally stands firm and uncompromising against the use of forced labor and takes all reasonable precautions to ensure, to the extent possible, that each of its vendors demonstrates good labour practices, including in their supply chain respectively.

The respect for human rights, labor laws, fair competition and environmental considerations are our guiding principles in our choices for procurement, outsourcing and even end users.
